Committee's Report

Tingara Netball Club For the year ended 15 October 2023

Treasurer's Report

The Special Purpose Financial Statements have been prepared for distribution to members and presentation at the Annual General Meeting. The annual reports are prepared and maintained by the Treasurer based off of the bank statements, which is reconciled using Xero.

At the end of the 2023 season, the balance sheet is made up of Cash (totalling \$48,923.97) and a small amount of Stock on Hand. The sundry Creditors as at 15 October 2023 relate to the final payments for the 2023 season (mainly for windup costs) and is high due to the club having to close the Bankwest account (as no longer supported) and we are waiting for the Bendigo Bank account to be opened. We finished the season with a profit of \$2,651.38 which is due explained as the profits from the annual Quiz Night that is held. In addition to this, we note that our membership fees were significantly higher than the 2022 season.

We had a couple of silver sponsors in the 2023 season (SoundLegal, Maysville Farm and Lifecare Physio) and a generous sponsorship from the O'Sullivans to support our Umpires.

During the season, Tingara Netball Club received a volunteers government grant. These grants go a long way to assist with the spending within the club, so a huge thanks to all those involved in organising.

Compared to our budgeted position, we spent an additional \$1,271 compared with our budgeted profit of \$3,922. There are a number of reasons for the variance, such as additional purchases of stock for our 10/15/20 year awards and spend on warm up tops for those members who had not received them last year but the overspending was met with higher membership fees (as mentioned earlier) and significant profit from the Quiz Night. Due to our strong cash position, the decrease in profit (against our budgeted profit) will not have a material impact but will be monitored moving forward.
